A 2001 or 2002 old Sea Ray 190 and a small sailboat, both of which reside in Hall Co.

The 3rd boat, a 2022 Sea Ray is docked at Port Royale Marina, and has been since we bought it. I mistakenly thought the marina was in Hall Co., but recently found out that it is in Forsyth, when I got a property tax bill due Nov. 15, 2024 from Forsyth, and I confirmed with the Marina that they are in Forsyth.

Please adjust my Hall County 2024 bill to remove our 2022 Sea Ray, as I will be paying the Forsyth bill.

Possibly worth noting as well, our 2001? Sea Ray 190 was left in the water this past winter and the engine block cracked and now will not run. So the old Sea Ray no longer has a working engine; I don't know how this may affect the property value, if you can consider that as well please.
