

**2024 Refund Request - Wurth Revcar Fasteners - Account #155031 - 1845 New Harvest Rd**

Approve the 2024 personal property refund in the amount of \$6,441.93 for the overpayment of Hall County taxes regarding account #155031 to Wurth-Revcars Fasteners.

The 2024 Business Personal Property Reporting Form and Freeport application for Wurth-Revcars was filed untimely (April 1 is the deadline). The return was not immediately worked, however a notice of assessment was mailed and no appeal was made. After the property owner paid the county property tax bill the owner discovered that Freeport Exemption was not included on the City of Gainesville bill, therefore discovering it was not on the Hall County tax bill as well. Freeport was not initially granted however, even with the late filing Wurth-Revcars is eligible to Freeport at 66.67%. Refund request is valid, and recommended.
