Therefore, owners, occupants, and users of the property shown on this plat should be prepared to expect the effects of such practices."
- 2. No variances or development exceptions are granted as part of this request that are not explicitly granted by Board approval. The development shall be compliant with the Unified Development Code of Hall County, as well as any other agencies or reviewing departments, including, but not limited to the Fire Marshal and Hall County Engineering.
- 3. All conditions of zoning shall be made a part of any plats or construction plans created for the development.
