After the time and in a designated room and place, the names of the companies submitting proposals will be publicly read. No further information will be read, discussed or provided until the evaluation of all submittals are completed. No extension of the proposal period will be made other than by a formal written addendum.

Hall County Board of Commissioners is soliciting submissions from companies that are interested in and capable of providing an inmate telephone system and related services for two (2) locations:

 The average daily male population is 781 and the average daily female population is 97. The minimum age is 17 years and the average age of inmates is 35 years.
 The total bed space capacity is 1,134 inmates. There are currently one hundred (100) non-coined telephones in the blocks with two (2) coin operated phones in the lobby.
- 2) The Hall County Correctional Institution located at 1694 Barber Road, Gainesville, GA 30507. The average daily population at the Correctional Institution is 200 of which the average age is 32 years. The total bed capacity is 240 inmates. There are currently sixteen (16) non-coined telephones.

A Pre-Bid Meeting and Site Inspection will be held on <u>Wednesday</u>, <u>August 26</u>, <u>2020 at 10:00 a.m.</u>, at the Hall County Jail located at 1700 Barber Road, Gainesville, Ga 30507. Hall County urges all prospective bidders to attend. Immediately following the pre-bid meeting, a tour of the facilities will be conducted for all parties interested in viewing the facilities. Questions arising during the tours should be submitted in writing in accordance with instructions listed in this document no later than Friday, August 28 by 5 p.m. We will have these answered in an addendum by Tuesday, September 1, 2020.

Firms must submit nine (9) copies of their proposal; one (1) of which must be marked as "Original" and eight (8) marked as "Copy". Proposals shall be enclosed in a sealed envelope or box clearly marked with "RFP #41-007 for "Inmate Telephone System & Services" in the lower, left corner. Proposals that do not clearly outline responses to each criterion may be eliminated from further consideration. Your submittal must have a signature in its "original form". Hall County suggests this is provided on "Introductory Letter". Failure to sign your proposal in the introductory letter will force your bid to be declared as "non-responsive" and not be considered for award. Your price proposal must be enclosed in a separate sealed envelope and marked as pricing.

These proposals will be evaluated using a multi-step process. The first step is to evaluate the "qualification" submissions. Factors and percentage of each category to be considered in the evaluation includes: introductory letter – 5%, firm experience and workload – 20%, firm personnel experience – 25%, IT system / requirements / implementation/ service / support / customer service – 25% and cost proposal – 25%. This step will result in a "shortlist of qualified firms". After the "short list" is compiled, the County may schedule interviews of the "short listed" consultants.

Successful proposer will be required to provide insurance in the amount of at least one million dollars (\$1,000,000.00) as required by paragraph 17 of the "Terms and Conditions" of these documents.

Failure to sign your bid in the proper space on the Proposal Form will force your bid to be declared as "Non-Responsive" and not considered for award.

No proposal may be withdrawn for a period of (60) sixty days after time has been called on the date of opening.

- 1. Changes: No change will be made to this Request for Proposal except by written modification by the County Purchasing Office. Requests for interpretation or changes must be in writing and received at least (10) ten calendar prior to the time set for opening of the proposals.
- 2. Signing of Proposal: Failure to sign your proposal in "original form" will force your bid to be declared as "non-responsive" and not considered for award.
- 3. Bid Acceptance Time: Bids requiring acceptance by the County in less than sixty (60) calendar days could be rejected, unless so stated and accepted by the County.
- Bid Identification: All bids submitted as a result of this Request for Proposal must be returned in a sealed envelope with the following information in the lower left-hand corner of the envelope: <u>RFP</u> <u>Number / opening date.</u>
- 5. Withdrawal of Bids: Bids may be withdrawn by written request only, if the request is received prior to the time and date set for the opening of bids. Contract (s), if awarded, will be on a lump sum basis or individual item basis, whichever is found to be in the best interest of Hall County.

9. Non-Discrimination:

- 9.1. Non-Discrimination: The vendor assures to provide services in a manner that does not discriminate on the basis of sex, race, creed, religion, color, national origin, age, veteran or military status, sexual orientation, gender expression or identity, disability, or the use of a trained service animal.
- 9.2. Americans with Disabilities Act (ADA): The vendor agrees to comply with Hall County's ADA notice and procedures. They are available upon request and are accessible on Hall County's website. - 10. Exceptions to Specifications: Any award resulting from this Request for Proposal shall bind the proposer to all terms, conditions, and specifications set forth in this Request for Proposal. Proposers whose proposals do not conform should so note on separate page if necessary and/or on the bid schedule. While the County reserves the right to make an award to a nonconforming proposer, when in the best interest of the County, such awards will not be readily made, and proposers are urged to conform to the greatest extent possible. No exceptions will be considered to have been taken by proposer unless it is properly set out as provided above. No exception will be deemed to have been taken by the County unless incorporated in an award resulting from this Request for Proposal and so stated.
- 11. Proposal Results: Interested parties may request, in writing, a bid tabulation after award of RFP has been approved by Board of Commissioners.

12. - 16. Execution of Contract: Subsequent to the award, the successful proposer will be presented with a contract. Contract is to be executed within ten (10) calendar days of "Notice of Award". The date of presentation shall be deemed to be the postmark date. Any work performed outside the contract agreement for which compensation over and above the agreement occurs; there must be an accompanying approved change order. If work is done before change order approval, the change may be rejected or denied for compensation.
- 25. Indemnity: Successful proposer agrees, if entering into a contract as a result of this Request for Qualifications, to defend, indemnify, and hold harmless Hall County from any and all courses of action or claims of damages arising out of or related to proposer's performance or actions or those of his/her employees or agents, under said contract.
- 26.
