Purpose of Request: Approve the ratification of the application of the Criminal Justice Coordinating Council's (CJCC) FY23 Accountability Court Language Access and Screening Tool to provide Spanish-speaking resources and materials to participants in the Hall County DUI Court program in the amount of \$94,646, and if awarded, appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents. An in-kind match of \$16,702 is required, which is satisfied using a CACJ state-funded salary currently assigned to the accountability court. If approved, requested grant funds will support a new part-time DUI Court case manager to be added to position control.		History:  Treatment Services is the umbrella agency that encompasses all of the accountability court programs in the Northeastern Judicial Circuit (Hall and Dawson counties). Our circuit currently operates multiple accountability court programs in Hall County (Drug Court, Mental Healt Court, Family Treatment Court and DUI Court), and operates a multitrack treatment court program in Dawson County with 4 distinct tracks (drug track, mental health track, family treatment court track, and DUI track). Between all our accountability court programs, we currently services offered 7 days per week. Treatment Services also operates a full-time drug testing lab which analyzes over 53,000 drug screens per year.					

Options:

Facts and Issues:

The Hall County DUI Court program currently has an active census of 77 participants and has been in operation since 2003. We currently have one Coordinator who manages the general operations of the program and one Case Manager who maintains the entire DUI Court caseload. The Case Manager is responsible for facilitating regular case management meetings with participants, tracking participant progress, data collection, data dissemination, and accurate and timely maintenance of court spreadsheets. We are requesting funding for a part-time bilingual case manager position to assist with our increasing number of Spanish-speakers in DUI Court. In 2024, we saw an 11% increase in our Hispanic/Latino population and this demographic now makes up 44% of our total active census. Spanish is the primary language for 17% of our program participants. Without adequate bilingual support, these participants often face significant barriers to understanding and fully participating in their treatment plans, court proceedings, and case management services.
