#### **TRACT ONE:**

All that tract of parcel of land lying and being in the City of Lula, Hall County, Georgia, consisting of .277 acres and being more particularly described according to a survey by Roy A. Terrell, registered Surveyor, dated October 26, 1994, recorded on Slide 391, page 1A, Hall County, Georgia, Plat Records. Reference to said plat and the record thereof is hereby made for a more complete description of said property.

#### **TRACT TWO:**

Reference to said plat and the record thereof is hereby made for a more complete description of said property.
