Approval and authorization for the Chairman to execute the Georgia Department of Transportation (GDOT) FY 2025 Local Roads Assistance (LRA) Grant application and cover letter for 5.68 miles of road resurfacing on eleven (11) various County roads, in the estimated amount of \$2,743,121.98.

Facts and Issues:

Based on the funding from GDOT FY25 LRA, the County is only submitting a condensed list that still maximizes the benefit of LRA funds but will allow Hall County to utilize the most recent road ratings for the Hall County FY26 Resurfacing List.

There is no cash match required for these funds.

The LRA list along with the previsouly approved LMIG list from last October will be combined and added to the Final FY 26 Resurfacing list that will be presented to the Board.
