Approve the single source purchase of one (1) TEK84 Intercept Whole Body Security Scanning System including training and three (3) years of additional warranty for the Hall County Jail to TEK84, Inc. of Poway, CA, in the amount of \$169,200.00.		History: The current body scanner at the Hall County Jail was purchased in 2017 and requires a very costly annual service agreement to operate and to receive software updates. The Sheriff's Office researched x ray body scanners and visited other facilities that use body scanners and the TEK84 provides all the necessary requirements: 1. Minimal X-ray dose of less than 1% 2. Current technology with clear images 3. Minimal footprint of '3x'6 instead of '8x'8 that we currently operate 4. Provides a photo ID link for evidence storage support

Installing the following:

- (1) Built in camera to include a photo of the subject with each scan.
- (2) Our agency's logo on the scanner, as well as on each scan report.
- (3) Training by a medical professional on the use of the product, required radiation training and expert training on reading the scan results.
- (4) A one-time grab of our JMS database to upload the current list of subjects currently and previously in our facility.
