  - Engineering: This site may require a stormwater management report should the site plan indicate the proposed development meets stormwater thresholds for impervious surfaces and/or disturbed acreage.
    Show stream buffer and impervious setback from wrested vegetation not

    - Show FEMA and Hall County studied Flood plains that are present on site.
  - b. Traffic: Code requires both a decel and left turn lane on Union church Road at development access.

Secondary access to union Church Road must be gated emergency access only or improvements will also be required.
