Whereas the Contractor thereby agreeing to this renewal to provide services previously supplied in accordance with the original agreement; and


Whereas, with both parties agreeing to the renewal as stated and therefore, the above numbered contract is hereby modified as follows:



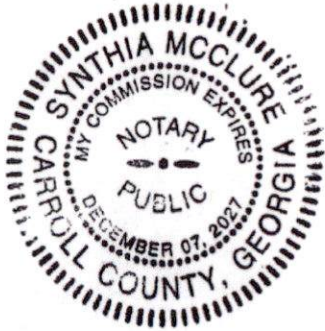
