Spout Springs Road Widening Phase Duluth, GA to update to all environment	Purpose of Request: Approve the Change Order #8 of RFP #31-014 Design Services for Spout Springs Road Widening Phase 2 to STV Incorporated of Duluth, GA to update to all environmental documents and traffic studies, in the amount of \$1,753,690.12.		History: The project was split in 2016 by GDOT into Phase I and Phase II. Phase I construction from Union Circle to I-985 was recently completed by GDOT. Phase II will begin south of the Union Circle Intersection and end south of the Thompson Mill Intersection, for a total length of 3.050 miles. Phase I of Spout Springs is completed with four lanes and is open through traffic which covers Hog Mountain Road to Union Circle.
