Approve Change Order #2 under RFQ/P #45-006 Inmate Food Service for the Hall County Jail to Kellwell Food Management of Beattyville, KY, in the amount of \$260,000.00.	This is the first year with this current food service provider, and the quality of service has been good.
<b>Facts and Issues:</b> Due to the volume of inmates housed at the Hall County Jail, a change order was needed to cover the remaining food costs of FY2025. This change order will bring the PO# 20250150 from \$1,100,000.00 to \$1,360,000.00. Funding for this increase will come from a combination of general fund contingency and operational savings.
