FIRST AMENDMENT TO PURCHASE AND SALE AGREEMENT

- 2. The Purchase Price of the Property shall be \$1,695,000.00.
- 3. The Inspection Period shall expire Fifteen (15) days from execution of this First Amendment.
- 4. Closing shall take place on or before Thirty (30) days following expiration of the Inspection Period.
