### (B) CASE BACKLOGS REQUIRED TO JUSTIFY ARPA FUNDS

All applicants must objectively demonstrate that case backlogs exist to qualify for ARPA grant funds or continued funding. All expenditures requested in this application must be "reasonably proportional" to the applicant's objectively demonstrated need to address case backlogs, with priority given to serious violent felonies (as defined in OCGA § 17-10-6.1 (a)). 87 Fed. Reg. 4,344; 4,388 (Jan. 27, 2022). When calculating the need for additional resources to respond to case backlogs, a court may provide statistics comparing its case volume from a "normal" pre-pandemic year (e.g., case volume in 2019) to its current case volume. Applicants should also identify what portion of case backlogs are serious violent felony cases, as defined in OCGA § 17-10-6.1 (a).

## (E) (1) Payroll-Public Sector Staff Responding to Case Backlogs (EC 3.1)

More than 50 percent of total personnel costs awarded each calendar year under this EC must be dedicated to responding to serious violent felonies, as defined in OCGA § 17-10-6.1 (a). As used in (E) (1) (c), "total personnel costs" means the subtotal of funds requested under section (E) (1) only, as stated in (E) (1) (a). To get the percentage used in (E) (1) (c), divide the amount provided under (E) (1) (b) by the amount provided in (E) (1) (a).

New or existing staff may be used to respond to case backlogs, with priority given to serious violent felony cases (as defined in OCGA § 17-10-6.1 (a)). However, only payroll for time spent actually responding to case backlogs may be reimbursed with ARPA grant funds. 87 Fed. Reg. 4,341; 4,388 (Jan. 27, 2022) (Eligible use must "respond to the identified negative economic impact" of the pandemic, "e.g., backlogs in court systems"). This includes payroll of new personnel hired to backfill existing personnel responding to case backlogs (prioritizing cases involving serious violent felonies). Therefore, time spent responding to case backlogs (or backfilling others so they can respond) must be tracked and documented for reimbursement and auditing purposes.

Per U.S. Treasury Compliance and Reporting Guidance, federal "EC 3.1" is reserved for "Public Sector Workforce" payroll and benefits, so (E) (1) must exclude contractors, which fall under federal administrative ECs "3.5" and "7.1." 31 CFR § 35.6 (b) (3) (ii) (E) (1). To categorize contractors correctly under federal guidance, request contractors responding to case backlogs generally (i.e., not performing mental health, substance use, or eviction prevention diversion services) under (E) (6), which corresponds to federal administrative expenditure ECs "3.5" and "7.1." 31 CFR § 35.6 (b) (3) (ii) (E) (3)-(4).

#### (E) (2) Court-Based Mental Health Diversion (EC 1.12)

Per Executive Branch limitations, ARPA funds for court-based mental health diversion services must: (a) respond to case backlogs; and (b) conserve staff time and resources to respond to case backlogs of serious violent felony cases, as defined in OCGA § 17-10-6.1 (a). Accordingly, for purposes of this expenditure category, grant applicants *must provide* a *numerical estimate* in the description regarding the staff hours and resources court-based mental health diversion services will conserve so staff may respond to serious violent felonies. As used in this section, "numerical" means containing one or more of the number symbols 0, 1, 2, 3, 4, 5, 6, 7, 8, or 9; e.g., 20 hours of staff time per week, 18 percent of a judge's caseload, or some other numerical measurement. Please also note that ARPA funds allocated to the Judicial Council may be used for court-based services only and not for out of court mental health treatment services.

Contractors performing court-based mental health division services to respond to case backlogs must be requested under (E) (2) and not (E) (6) because federal "EC 1.12" applies to "Mental Health Services" generally. 31 CFR § 35.6 (b) (3) (i) (C).

#### (E) (3) Court-Based Substance Use Diversion (EC 1.13)

Per Executive Branch limitations, ARPA funds for court-based substance use diversion services must: (a) respond to case backlogs; and (b) conserve staff time and resources to respond to case backlogs of serious violent felony cases, as defined in OCGA § 17-10-6.1 (a). Accordingly, for purposes of this expenditure category, grant applicants must provide a numerical estimate in the description regarding the staff hours and resources court-based substance use diversion services will conserve so staff may respond to serious violent felonies. As used in this section, "numerical" means containing one or more of the number symbols 0, 1, 2, 3, 4, 5, 6, 7, 8, or 9; e.g., 20 hours of staff time per week, 18 percent of a judge's caseload, or some other numerical measurement. Please also note that ARPA funds allocated to the Judicial Council may be used for court-based services only and not for out of court substance use treatment services.

Contractors performing court-based substance use diversion services to respond to case backlogs must be requested under (E) (3) and not (E) (6) because federal "EC 1.13" applies to "Substance Use Services" generally. 31 CFR § 35.6 (b) (3) (i) (C).

#### (E) (4) Court-Based Eviction Prevention and Diversion (ECs 2.2, 2.18)

Per Executive Branch limitations, ARPA funds for court-based eviction prevention and diversion services must: (a) respond to case backlogs; and (b) conserve staff time and resources to respond to case backlogs of serious violent felony cases, as defined in OCGA § 17-10-6.1 (a). Accordingly,

for purposes of this expenditure category, grant applicants *must provide* a *numerical estimate* in the description regarding the staff hours and resources court-based eviction prevention and diversion services will conserve so that staff may respond to serious violent felonies. As used in this section, "numerical" means containing one or more of the number symbols 0, 1, 2, 3, 4, 5, 6, 7, 8, or 9; e.g., 20 hours of staff time per week, 18 percent of a judge's caseload, or some other numerical measurement. *Please also note that ARPA funds allocated to the Judicial Council may not be used for direct payments to landlords or tenants.* 

Contractors performing court-based eviction prevention and diversion services to respond to case backlogs must be requested under (E) (4) and not (E) (6) because federal ECs "2.2" and "2.18" respectively apply to "Household Assistance: Rent, Mortgage, and Utility Aid" and "Housing Support: Other Housing Assistance" generally. 31 CFR § 35.6 (b) (3) (ii) (A) (1), (5).

### (E) (6) ARPA-Eligible Administrative Expenses (ECs 3.5, 7.1)

No staff or contractor positions should be requested under this EC, which is reserved for "audio-visual equipment modernization" expenditures only, as defined in the AV Policy. #### (A) USE OF ARPA FUNDS SUMMARY

The Northeastern Judicial Circuit was awarded a total of \$1,680,497, in two separate cycles, for the year 2022, \$2.5M, in two separate cycles, for the year 2023, and \$1,870,431 for the year 2024/2025. The awards have been enormously helpful, as it included funding for a total of 5 new full-time positions across both Hall and Dawson Counties in 2024/2025.

The biggest barrier to implementation has been hiring. While several positions were filled within four weeks of the award, some ARPA-funded positions have taken as long as 8 months to make a hire. Additionally, every department and agency has faced unusually high levels of turnover in 2022 and 2023, and employees have consistently been shuffled around into new positions.

Administratively, the primary barrier to implementation has involved the Judicial Council clarifying grant reporting requirements. Significant staff resources are continuing to be spent on procedures and policies that are later revised, amended, or ended. Some of these challenges have receded, thankfully, but it continues to be an administrative strain. A lesser barrier

involved the task of coordinating funding across two counties where only one county may be designated to receive the reimbursement funds.

The availability of Senior Judges has been a concern, and something closely monitored as circuits across the state ramped up their requests. This circuit has mitigated that concern by relying heavily on local, qualified judges from other classes of court assisting in Superior Court.

## (B) CASE BACKLOGS REQUIRED TO JUSTIFY ARPA FUNDS

### (1) Description of Case Backlogs

Case backlogs have improved due to record-high clearance rates and fewer new cases being indicted or accused in Hall County. Pending case counts as of December 31, 2024, across both counties, are near pre-pandemic levels.

Most significantly, the circuit achieved a 162% clearance rate of serious violent felonies in 2024, as the courts prioritized those cases for trial and disposition. This was a result of the resources provided by ARPA and the extraordinary efforts of all involved.

When unindicted criminal cases are included, total pending caseloads have declined every year since 2022 and are now only slightly elevated above pre-pandemic numbers. As of December 31, 2024, this number is 7.5% higher than at the end of 2019.

In 2024, many pandemic-delayed cases moved to a post-adjudication stage as charges were resolved. However, these cases continue to create significant challenges for both counties in the circuit as census numbers in our Treatment Court programs and Probation departments have increased. This application reflects that shift, asking for increased resources in those stages of criminal resolutions.

## (3) County Resources Provided to Courts

The judicial system has worked closely with officials from both Hall and Dawson counties to respond to the COVID-19 crisis and the ensuing challenges presented by the backlog of cases. While early funding conversations focused narrowly on federal relief funds, subsequent discussions have focused less on the specific funding source and more on the project need. This has allowed both counties maximum flexibility to qualify and administer their ARPA and CARES Act funding as they deem fit.

As eligibility guidelines from OPB became clear, the courts have focused requests to the Judicial Council's ARPA committee on temporary positions and spaces, while the counties have provided needed infrastructure and facility upgrades. In addition, both counties have funded permanent, additional pretrial officer positions as a result of the pandemic.

Specifically, Hall County Commissioners have funded the installation of broadband internet at the courthouse, the conversion of every single trial courtroom into a "hybrid courtroom" capable of facilitating remote video hearings, the purchase of new software, and the redesign of the circuit website to facilitate livestreaming and public access. Most significantly, capital funds have been approved to purchase a new office building to house growing staff, and to construct a new, expanded jury assembly room. It is unknown if any of the monies for these projects come from County ARPA funds.

Dawson County Commissioners have also provided funding to enable remote video hearings in each courtroom and funded new invoicing software to handle growing caseloads. It is unknown if any of the monies came from County ARPA funds.

Finally, in an effort to address staff shortages, both counties have considered and approved various pay increases and cost-of-living adjustments for employees.

### Two (2) New Positions:

Probation Officer (Hall County)- Salaried at \$55,000 for the period June 1, 2025-December 31, 2025. Our current domestic violence caseload sits at 414 cases and is supervised by one PO. These cases require more intensive supervision than the typical case due to the increased potential for harm to Hall County residents. Additionally, the average caseload for the office is approximately 260 cases per officer which exceeds office best practices and is above industry standards for similarly situated offices. An additional officer would be assigned specifically to the domestic violence caseload, providing assistance in this critical area. Increased staff would also reduce the probationer to officer ratio, better equipping the office to provide the citizens of Hall County excellent service. These funds will provide the temporary assistance needed to hire one probation officer in June 2025.

Probation Sentence Writer – Salaried at \$46,000 for the period June 1, 2025-December 31, 2025. Recent case management system changes and updated processes have altered staff work flow in the courtroom. As a result, the number of personnel required to perform the functions in court increased. Due to the additional personnel required in court, office staff are frequently

required to work in the courtroom, impacting on their ability to perform other duties. This can create delays in important administrative tasks. This position would be a supplement to current court personnel. These funds will provide the temporary assistance needed to hire one new sentence writer in June 2025.

### One (1) New Position:

Treatment Services Coordinator - Salaried at \$68,000 for the period June 1, 2025-December 31, 2025. Due to the restructure of treatment programming and the blending of counseling services for the Hall County Drug Court, Hall County HELP Court, and Hall County Family Treatment Court, Treatment Services has recognized the need to create a new Treatment Coordinator position to administratively supervise all counselors and treatment providers working for the agency. The Treatment Coordinator will work directly under the Assistant Director and will be the point of contact for all treatment-related issues, such as group coverage and treatment curriculum oversight and implementation, auditing and quality control of agencywide counseling services, and weekly meetings with all counseling staff to ensure efficient communication across all programs. This position will be essential for ensuring that counseling services continue to run smoothly for the agency. These funds will provide the temporary assistance needed to hire one new sentence writer in June 2025.

#### Additional Information

The Northeastern Judicial Circuit is fortunate to have a robust accountability court system operated under the umbrella agency of Treatment Services.

One-hundred percent (100%) of the funds requested will be used for court-based substance use services, and one-hundred percent (100%) of funds will be used to conserve resources in order to prioritize serious violent felonies.

Numerically, this request will facilitate the removal of around 250 felony cases from the circuit's trial calendars this year, allowing the judges to prioritize serious violent felony trials. This represents approximately 15% of the circuit's projected felony filings. Every drug case that our Treatment Services agency is able to staff appropriately is a non-serious case directly removed from the court's trial calendars. The seven requested positions will not directly touch serious

violent felonies, since such cases are ineligible for Drug Court admission, but every hour devoted to diversion directly impacts the circuit's ability to prioritize serious cases for trial.
