Purpose of Request:

Approve the renewal of the annual contract for RFQ/P #43-004 Sewer System Operations Service for Public Works & Utilities to ClearWater Solutions, LLC of Auburn, AL. The estimated annual cost is \$1.229.559.00.

Facts and Issues:

This is year four (4) of a five (5) year contract. As part of the contract, Clearwater will perform a service to rate the condition and inventory of the County's existing sewer lines over the five-year contract period.

This includes the cost for Repairs and Maintenance and Chemicals needed to operate the plant and the approx 25+ county maintained liftstations.

Previously FY 2025 total approval for Clearwater is \$1,155,403 and this contract renewal represents a 6.45% increase. This is partially due to managing operations while the plant is undergoing expansion.

ClearWater Solutions, LLC is the current contract holder and is a vendor in good standing with the County.
