Approve the renewal of annual contract for IFB #005-45 Firefighting Equipment for Fire Rescue to North America Fire Equipment Co., Inc. (NAFECO) of Decatur, AL. The estimated annual cost is \$275,000.00.

Facts and Issues:

This is year two (2) of a possible five (5) year contract.

Fire and Rescue must replace thirty-eight (38) sets of turnout gear for FY 2026 due to expiration per industry standards. Fire and Rescue will also need to purchase an additional ten (10) new sets for the current recruit class hence the \$275,000.00 estimated spend for FY 2026.

NAFECO has requested a three percent (3%) price increase for FY 2026 due to the increase of materials and manufacturing which has been approved by Fire Rescue.
