Roll-Off Solid Waste Hauling Services

Whereas, Contract #45-015 between Hall County, Georgia, (herein "County") located at 2875 Browns Rd., Gainesville, Georgia 30504 and North GA Excavation Group, LLC (herein "Contractor") located at 6946 County Line Rd, Lula, GA 30554, (herein "Parties") is in effect, and

Whereas, the Parties desire to renew the contract period for one (1) additional year term, and my mutual agreement, the Parties desire to Amend the contract's term of service from its original term of August 15th, 2024 through August 15th, 2025, to now read: July 1, 2025 through June 30, 2026, in order to align the term dates with the County's Fiscal Calendar, and

Whereas, Contractor thereby agrees to provide the same services as previously supplied in accordance with the original contract Scope of Work, Terms and Conditions, and

Whereas, the Contractor request a five-percent (5%) price increase for services beginning July 1, 2025, and the County finds the request fair and reasonable and is acceptable to both Parties and agree to the pricing of \$15,144.23 per week, and \$787,500.00 cost per year, as shown on Attachment "A", and

Whereas, the Contractor has requested that the Performance and Payment bond requirements contained in Article #123 of the original Roll-Off Solid Waste Hauling Services -Rebid Contract #45-015 be removed, the County finds that the Contractor has thus far fully satisfied its obligations under the contract, and has abided by all Terms and Conditions, and as such the County and the Contractor hereby agree to amend the contract, through this renewal, to remove the performance and payment bond requirements of Article #123 of the original Roll-Off Solid Waste Hauling Services-Rebid Contract #45-015 entered into on August 15th, 2024, henceforth, and

Therefore, with the above modifications to the original contract set forth herein, the Parties hereto agree that all terms and conditions of the original agreement will remain in full force and effect and legally binding on both parties,
