Comment:

Year four (4) of a five (5) year contract. Renewal FY 2026. As part of the contract, Clearwater will perform a service to rate the condition and inventory of the County's existing sewer lines over the five-year contract period. This includes the cost for Repairs and Maintenance and Chemicals needed to operate the plant and the approx. 25+ county maintained liftstations. Previously FY 2025 total approval for Clearwater is \$1,155,403 and this contract renewal represents a 6.45% increase. This is partially due to managing operations while the plant is undergoing expansion.

The FY 2026 Estimated amount has been reviewed against the projected FY 2026 budget by Finance.

Whereas, the County desires to Renew the Contract period for a one-year period through June 30, 2026, in accordance with the terms and conditions of Bid #43-004, Operations Service Contract for Hall County Sewer System Annual Contract for dated May 7, 2022; and

Whereas, the Contractor has agreed to this extension and agrees to provide services and/or materials previously supplied in accordance with the original agreement; and

Whereas, with both parties agreeing to the Renewal as stated and therefore, the above numbered contract is hereby changed as follows:

1. By extending the Contract Term through June 30, 2026,
2. Allow for price adjustments as agreed to and recorded in Attachment A,
3. Change Orders: Any and all change orders requested by the successful bidder on this project must be approved in writing prior to any work being performed. Any work performed outside the contract agreement for which compensation over and above the contract is requested must have an approved Change Order. If work is done before approval of a Change Order, the subsequent Change Order will be rejected.

Therefore, With the above change to the original contract set forth herein, the parties hereto agree that all terms and conditions of the original agreement will remain in full force and effect and legally binding on both parties.


