- 6) No junk vehicles, scrap materials, or parts shall be visible from the site. All materials utilized in service of vehicles shall be stored in an enclosed building.
- 7) Any new lighting on the premises shall be of a non-spill type.

Pursuant to section 17.380.130 of the Official Code of Hall County, the approval of any application for a use subject to approval of the county commission shall be effective for a period of no longer than 12 months from the date of approval unless action is taken by the applicant to implement the use proposed in the application by
