#### Purpose of Request:

Approve the award of IFB #012-46 Waste-Refuse Collection Services Annual Contract for various County departments to Red Oak Sanitation, LLC of Cumming, GA. The estimated annual cost is \$87,972.00.

After sending Red Oak Sanitation LLC a Request for Clarification concerning the replacement of the current vendor's dumpsters, and discussions with several departments, the County will be awarding this contract to Red Oak as they were the lowest bidder for solicitation IFB #012-46. Red Oak will be a new vendor for the County beginning July 1, 2025.
