#### Purpose of Request:

Approve Change Order #1 to Task Order #2025-006 under RFP/Q #42-002 Demand Services for Resurfacing, Paving, and Full Depth Reclamation for the FY 2025 resurfacing program to Allied Paving Contractors, Inc. of Pendergrass, GA, in the amount of \$1,619,967.15.

#### History:

Task Order #2025-006 stems from Contract #42-002 Demand Services for Resurfacing, Paving, and Full Depth Reclamation.

This task order was awarded to Allied in July 2024 by the BOC.

Allied Paving is a current vendor for Hall County and has been for several years. They are in very good standing within the County.

#### Facts and Issues:

The change order is to Resurface and Full Depth Reclamation of Cagle Road that is outside the scope of the RFQ/P #45-001 Cagle Road Improvements. This will provide for improvements to made to the entire Cagle Road between White Sulphur Road and SR365 including widening 2' on each side of Cagle Road.

The task order is associated with the annual resurfacing program. The funding source is LMIG.
