Due to the current tariff situation the price of imported tires cannot be secured for the term of the contract period. At present, the prices with Harrision Tire are the same as last year but may change depending on supply availability and tariffs. Kesler made their price list available for FY 2026 - see Attachment A. Every effort will be made by both vendors to keep the cost increase at a minimum. There are no price increases for any of the services offered or on tubes and valves from the previous year's pricing.
