Purpose of Request:

Approve the FY26 contract with the State of Georgia Department of Human Services for the Hall County Treatment Services to provide drug screening services and appoint the Treatment Services Director as the Program Designee and authorize the Chairman to execute all related award documents.

History:

Treatment Services has been providing drug testing services for Hall and Dawson County Department of Family and Children Services for the past 17 years. Since 2013, Treatment Services has entered into formal agreements with DFCS regarding drug testing services and has been awarded contracts annually. This contract period is from July 1, 2025 to June 30, 2026.

Facts and Issues:

Beginning in FY20, the Department of Human Services (DHS) transitioned to a new state-wide contract and pricing agreement. Treatment Services was awarded a non-standard contract to provide drug testing services for our local DFCS offices which has been extended annually. Treatment Services collected 1,718 DFCS screens in 2024. In FY24, DFCS screens resulted in a revenue stream of \$148,172, which assists in personnel and operational costs.
