### **Purpose of Request:**

Approve the withdrawal of Hall County's objection to the City of Flowery

Branch's annexation of the property of Joy Strickland Pearson, Trustee of the Dorothy P. Strickland Revocable Living Trust Dated June 18, 2008, located at 4381 Hog Mountain Road, Flowery Branch, GA 30542, and bearing Hall County Tax Parcel 15046 000001, following the applicant's withdrawal of the annexation application on June 25, 2025.

#### Facts and Issues:

The Department of Community Affairs, by its adopted rules, requires that the Hall County Board of Commissioners vote to withdraw its annexation objection to the subject property for Hall County's request for an arbitration panel to be rendered moot in accordance with Ga. Comp. R. & Regs. R. 110-12-8-.03(9)(e).

### History:

On May 22, 2025, the Hall County Board of Commissioners by unanimous vote approved a Resolution Objecting to the City of Flowery Branch's Annexation of the Property of Joy Strickland Pearson, Trustee of the Dorothy P. Strickland Revocable Living Trust Dated June 18, 2008, Known as Hall County Tax Parcel 15046 000001. On May 23, 2025, Hall County timely served notice of its objection to the City of Flowery Branch and the Department of Community Affairs. The applicant, Grand Communities, LLC, subsquently withdrew the annexation application on June 25, 2025.

#### Options:

Hall County, by a majority vote of its elected body, is permitted under the rules and regulations of the Department of Community Affairs to withdraw its annexation objection at any time for any reason during the arbitration process.
