Willys Countertops was discovered as a Business Personal Property		
account in calendar year 2022 from a business license. Willy		
Quinteros owned two businesses, Willys Mechanical, LLC which was		
already on the tax digest and the new business of Willys Countertops.		
For tax year 2023 Willys Countertops was added as a business personal property account and a business personal property form was mailed in 2022, however, the form was not returned.		
Therefore, the fair market value of the business equipment, furniture,		
and inventory for Willys Countertop was estimated at \$20,000. An		
assessment notice was mailed for 2023 on May 12, 2023; no appeal	Approve or deny refund.

The property owner paid the 2023 bill on $04/01/2025$ and emailed		
the request for refund on $04/02/2025$ stating the business closed on $01/31/2023$ .

recommend approval of the refund as January 1 is the lien date or		
date of appraisal in Georgia. Therefore, staff and the Board of		
Assessors recommend denial since the business did not close until
