Mr. Parsons has a slip at a Hall County marina where he keeps his 1999 Sea Ray 340 Sundancer. Mr. Parsons resides in Cherokee County. Being that the boat is located in Hall County the personal property taxes are to be paid to Hall County.

Mr. Parsons believes that the school tax on his boat is improper and illegal since he is not a Hall County resident. Mr. Parsons also believes that he should be exempt from school tax in Hall County since he is exempt from school tax in Cherokee County where he resides.

Personal Property does not qualify for a homestead exemption. Homestead exemptions are for Real Estate only, 48-5-40.3 states the following:

Approve or deny refund.

(3) "Homestead" means the real property owned by and in possession of the applicant on January 1 of the taxable year and upon which the applicant resides including, but not limited to, the land immediately surrounding the residence to which the applicant has a right of possession under a bona fide claim of ownership.

We recommend denial of the refund because there is no exemption for age and school taxes on Personal Property.
