The above-described property is conveyed subject to the following restrictive covenants:

1. For a period of five years from and after the date of this deed, the above-described property shall not be developed or disturbed and no structures may be placed thereon, other than a maximum of two driveways which conform to the same standards applicable to driveways in the Stone Creek at the Reservoir Subdivision.

2. Grantor and its successors and assigns may place and maintain landscaping on the above-described property within twenty-five feet of the boundary line between the above-described property and the Stone Creek at the Reservoir Subdivision beginning at a point 350 feet from Cornelia Highway. The landscaping is to be installed at the expense of Grantor, its successors or assigns pursuant to a landscaping plan furnished to and approved by Grantee.
