A RESOLUTION ABANDONING A PORTION OF A PUBLIC ROAD, BARKER ROAD AND ASSOCIATED RIGHT OF WAY, TO AMERICA'S HOME PLACE INC. AND ACCEPTING THE DEDICATION OF RIGHT OF WAY ALONG BARKER ROAD FROM AMERICA'S HOME PLACE INC. FOR CONSTRUCTION OF A CUL-DE-SAC

WHEREAS, Hall County, Georgia has the authority pursuant to O.C.G.A. § 32-7-1 to abandon any public road that is under its jurisdiction, if such abandonment is deemed to be in the public interest; and

WHEREAS, the said portion of Barker Road and associated right-of-way sought to be abandoned to America's Home Place Inc. is delineated as Parcel "A" on the plat attached hereto as Exhibit "A"; and

WHEREAS, the proposed right-of-way to be dedicated by America's Home Place Inc. to Hall County for the construction of a new cul-de-sac is delineated as Parcel "B" on the plat attached hereto as Exhibit "A"; and

WHEREAS, after a public hearing and due consideration, it appears that the property sought to be abandoned is no longer needed for public road purposes because it has ceased to be used by the public to the extent that no substantial public purpose is served by it currently, and it further appears to be in the best interest of all concerned as well as in the best interest of the public and of Hall County, Georgia to abandon the aforementioned portion of Barker Road and associated right-of-way to America's Home Place Inc. as America's Home Place Inc. owns all the property adjacent to the portion of Barker Road and the associated right-of-way to be abandoned and as such are the only entity positioned to make use of the property; and

WHEREAS, after public hearing and due consideration, it appears that the property sought to be dedicated is necessary for the County to obtain in order to best serve the public of Hall County; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Hall County, Georgia, at its regular meeting duly assembled, that Parcel "A", as shown on the Exhibit "A", a copy of which is on file in the Office of this Board, be and the same is hereby abandoned to America's Home Place Inc. and that Parcel "B" as shown on Exhibit "A" a copy of which is on file in the Office of this Board, be and the same is hereby accepted from America's Home Place Inc.

BE IT FURTHER RESOLVED that the Chairman of the Board of Commissioners of Hall County, Georgia be, and is hereby authorized and directed to execute any and all documents necessary to effectuate the abandonment of the portion of Barker Road and associated right-of-way described in Exhibit "A" as Parcel "A" and that the Chairman of the Board of Comissioners of Hall County is further authorized and directed to execute any an all documents necessary to effectuate the acceptance of the right-of-way described in Exhibit "A" as Parcel "B".
