### SUPPLEMENTAL AGREEMENT NO. 2 FOR AN EXECUTED MEMORANDUM OF AGREEMENT

## BY AND BETWEEN GEORGIA DEPARTMENT OF TRANSPORTATION AND HALL COUNTY FOR PRELIMINARY ENGINEERING

## Original PE Oversight \$ 40,000 REVISED PE OVERSIGHT \$ 110,000

THIS AGREEMENT is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_, by and between the Georgia Department of Transportation, an agency of the State of Georgia (hereinafter called the "DEPARTMENT"), and HALL COUNTY, Georgia acting by and through its Board of Commissioners (hereinafter called the "LOCAL GOVERNMENT" or "SPONSOR").

WHEREAS, the DEPARTMENT and LOCAL GOVERNMENT heretofore entered into a Memorandum of Agreement dated <u>November 1, 2023</u>, Contract ID Number IGOPD2400650, hereinafter called the "Original Agreement", which was modified by Supplemental Agreement Number 1 dated January 2, 2025, for the purpose of the LOCAL GOVERNMENT funding the DEPARTMENT's expenses associated with PE Oversight for Spout Springs Road from Union Circle S of SR 347 – Phase II (PI 0015280), hereinafter referred to as the "PROJECT"; and

WHEREAS, due to the Preliminary Engineering Oversight (hereinafter called "PE Oversight") funds being depleted within \$5,000.00 of the remaining PE Oversight balance and the PROJECT activities and tasks are still outstanding, the Department has elected to exercise its reserved right to request additional funds from the LOCAL GOVERNMENT pursuant to Section 3.c. of the Original Agreement; and

WHEREAS, the DEPARTMENT policy requires, and the LOCAL GOVERNMENT has agreed, that the LOCAL GOVERNMENT shall fund the DEPARTMENT expenses associated with PE Oversight for the PROJECT and

NOW THEREFORE, the ORIGINAL AGREEMENT is hereby modified to reflect that the LOCAL GOVERNMENT shall fund any additional DEPARTMENT expenses associated with PE Oversight for the project in excess of the amounts set out in the ORIGINAL AGREEMENT.

Sections 3.a. through 3.c. of the ORIGINAL AGREEMENT, PAYMENT BY THE LOCAL GOVERNMENT TO THE DEPARTMENT, is deleted in its entirety and replaced with the following:

# 3. PAYMENT BY THE LOCAL GOVERNMENT TO THE DEPARTMENT

a. Subject to the provisions of this section, the LOCAL GOVERNMENT will be responsible for providing payment of <u>\$60,000 and 00/100</u> (One Hundred Ten Thousand Dollars and zero Cents) to the DEPARTMENT within three (3) days after the execution of this Agreement.

b. All payments by the LOCAL GOVERNMENT to the DEPARTMENT shall be sent to the following address:

c. The DEPARTMENT reserves the right to request additional funds from the LOCAL GOVERNMENT for PE Oversight, such additional funds to be determined by the DEPARTMENT. If, as determined by the DEPARTMENT, at any time the PE Oversight funds are depleted within \$5,000 of the remaining PE Oversight balance and PROJECT activities and tasks are still outstanding, the LOCAL GOVERNMENT shall, upon request, make additional payment to the DEPARTMENT. The payment shall be determined by prorating the percentage complete and calculating the balance required to complete stated activities. Until such time as applicable requested additional PE Oversight is received, the DEPARTMENT shall not conduct further project activities.

Except as modified, changed or amended, all terms and conditions of the Original Agreement dated November 1, 2023, as modified by Supplemental Agreement Number 1 dated January 2, 2025, shall remain in full force and effect.

The WHEREAS clauses hereto are a part of this Supplemental Agreement No .2 and are incorporated herein by reference.

The ORIGINAL AGREEMENT, as amended by Supplemental Agreement Number 1 and this Supplemental Agreement Number 2, constitutes the full, complete and entire understanding between the DEPARTMENT and the LOCAL GOVERNMENT.

IN WITNESS WHEREOF, the DEPARTMENT and the LOCAL GOVERNMENT have caused these presents to be executed under seal by their duly authorized representative.
