Purpose of Request:

Approve the single source purchase of consulting services from Burns & McDonnell of Atlanta, GA to facilitate permit renewal and major modifications to the Candler Road Landfill, in the amount of \$319,400.00.

History:

Hall County Georgia owns the Candler Road Landfill (Landfill) which has been in operation since 1996. The existing solid waste permit at the Landfill was most recently renewed in 2020.

Facts and Issues:

Starting in 2019, the Georgia Environmental Protection Division (EPD) requires solid waste permits to be renewed every 5 years. The Landfill solid waste permit is required to resubmit their renewal application in calendar year 2025 or early 2026. The original permit written in 1996 when renewed in 2020 did not include significant changes to the design including updates to the stormwater, road design, final cover considerations, or various other items to account for better design strategies and technologies since the original permit's creation.
