Purpose of Request:

Approve the award of RFQ/P #46-018 Impact Fee Study for Public Works & Utilities to TischlerBise, Inc. of Bethesda, MD, in the amount of \$129,380.00.

History:

Currently, Hall County's impact fees are categorized as various public facilities including libraries, parks, and public safety facilities (fire rescue, EMS, and law enforcement including the County jail, personnel and related equipment of the Sheriff's Office. There is not currently a roads category for impact fees.

Tischler-Bise prepared an Impact Fee Study for neighboring Forsyth County.

The recommended vendor's fee is below the approved FY26 budgeted cost.

Facts and Issues:

Options:

The primary purpose of impact fees in Hall County is to ensure that new development contributes a share of the costs associated with providing public services to those new residents. This helps to prevent new growth from placing an undue burden on existing infrastructure.

The impact fee study will provide a recommendation for fees that can support road improvement infrastructure costs that ensure level of service is maintained even with new developments.

The impact fee study will provide the support and documentation necessary to revise the county's current impact fee structure and comply with the Development of Community Affairs applicable requirements.

The study is estimated to take 90 days from Notice to Proceed.
