Purpose of Request:

Approve the ratification of the application for grant funds from the Georgia Opioid Crisis Abatement Trust in the amount of \$276,914.00 to provide funding for transportation assistance, a full-time counselor to assist with drug treatment for the REACT program, audio-visual equipment and subscriptions that will help provide telehealth options for treatment, and training opportunities for additional staff to attend the All RISE conference. If awarded, appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents as well as add one full-time counselor to position control. There is no match requirement.

History:

Treatment Services is the agency which operates all accountability court programs in our judicial circuit. The agency provides comprehensive treatment services, including substance abuse treatment, to program participants in the area we serve. This community has been impacted significantly by the opioid epidemic. Treatment Services seeks to mitigate the effects of Opioid Use Disorder (OUD) by providing programming to target this problem among criminal justice involved individuals.

Facts and Issues:

Options:

Treatment Services provides comprehensive mental health and drug and alcohol services to high-risk, high-need individuals involved in the criminal justice system. We provide an alternative to incarceration by offering intensive and individualized treatment to those suffering from mental health and substance use disorders. Opioid Use Disorder (OUD) remains prevalent in our community, and Treatment Services is seeking grant funding from the Georgia Opioid Crisis Abatement Trust to facilitate better outcomes for those in treatment. The Georgia Opioid Crisis Abatement Trust was created to administer Georgia's share of funds from national settlements with opioid manufacturers or distributors.
