### Purpose of Request:

Approve the annual contract for Planned Pethood Veterinary Services for Animal Services to Planned PEThood of Georgia of Duluth, GA. The estimated annual cost is \$241,800.00.

### History:

Animal Services has used Planned Pethood in the past for various services and is in good standing within the County.

### Facts and Issues:

This agreement is for Planned Pethood of Duluth, GA to provide veterinary services to Hall County Animal Services in the amount of \$241,800.00. Staff recommends entering into this agreement with Planned Pethood due to the comprehensive scope of services they offer, which will enable Animal Services to continue delivering efficient and high-quality care for both the animals and citizens of Hall County.

The budgeted amount of \$241,800.00 reflects services to be performed by Planned PEThood three (3) days per week for the term of the contract.

This service is an exemption under the Purchasing Ordinance via Hall County Code Section 3.10.030 - Exemptions / Letter J for Licensed Health Professionals that includes Veterinary Services.
