SPECIFICATIONS and SCOPE OF WORK:

This is a turnkey project. The awarded contractor shall provide all equipment, labor, materials, permits, and supervision necessary to satisfactorily complete the project.

- Remove and dispose of existing Carrier air conditioning units 1B and 2B on gymnasium rooftop.
- Furnish and install two (2) new air conditioning units that will serve the gymnasiums.
 - Acceptable manufacturers: York only. Match model of units 1A and 2A that were recently replaced.
 - The new units must be installed per the manufacturers' instructions and must meet all local, state, and national codes and requirements.
 - Ensure the proper tonnage, BTU heat and blower CFMs must match the tonnage of the BTU heat and blower CFM of the existing Carrier units 1B and 2B.
- Condensate drains shall be PVC and shall have a union at the connection to each unit.
- The County prefers that the new units be able to drop right onto the existing curb.
 - o Alternate proposals that fit without a curb adapter, or a short adapter, will be considered.
- Remove the existing thermostat and give it to Hall County Central Services Department.
 - o **DO NOT** dispose of the thermostat.
- Furnish and install one (1) new Honeywell 8000 Wi-Fi thermostat.
- Include one (1) case of each size filter for each unit.
- Furnish one interface dongle, part number JCIoTM5StickCkit.
- Include cut sheets or other manufacturer's documentation with your bid.
- Label each unit with outdoor rated label.
- Include Five (5) year parts and labor warranty on all work and equipment at no additional cost to the County.
- Alternate: Replace RTU 9 that meets all specifications for replacing units 1B and 2B listed in this bid.
