Hey Kaitlyn – see below for comments from the MPO:

- 6. NCP Holdings, LLC 4020 & 3886 Cornelia Highway/4761 Cagle Mille Road
 - These parcels are along State Route 365, which is expected to be widened with construction scheduled for 2035 (GH-150/PI0020731). This project is currently undergoing pre-engineering by GDOT, where further details, including right-of-way impacts, will be established. Applicant should coordinate with GDOT District 1.
- 10. Academy P1 Building, LLC 5970 Cleveland Highway
 - This parcel is along US 129, which is expected to be widened with construction scheduled for 2040 (GH-035/PI0014129). Pre-engineering is scheduled for 2035, where further details, including right-of-way impacts, will be established.


