The purpose of this letter is to confirm the availability of water service to the above referenced property.

The City of Gainesville owns and operates an existing 12-inch ductile iron water main in the right-of-way of Old Winder Highway.

Currently, the City has adequate domestic water capacity to serve the proposed residential components of your proposed mixed-use development. The warehouse components of the development will be reviewed upon submittal based on the water demands of each prospective tenant. This letter of water availability <u>does not</u> guarantee or confirm fire flow pressures and/or volumes for fire protection systems related to the proposed warehouses.

This confirmation of water availability is good for one year from the date of this letter at which time, it will become null and void unless engineered plans have been submitted for issuance of a development permit.

Hi Katie,

With respect to this project and others in the future requiring letters of water availability, The City of Gainesville will confirm (or deny) the availability of **domestic** water service for a proposed development. However, the City <u>cannot</u> confirm or guarantee adequate fire protection water volumes or pressures for a proposed fire protection system that may be needed for a development. Any fire protection water demands above and beyond the capability of the City's existing water system must be mitigated by the developer at the sole expense of the developer.

Please see our comment in black and the applicant response in red. Can you confirm the accuracy of this and if they need anything more from your end? Site plan and narrative attached.

No water commitment for the industrial site; narrative notes review will be case-by-case per tenant
demand. Applicant requests a guaranteed minimum amount of water service for warehouse space, and
anything beyond the standard shall be reviewed on a case by case basis. Applicant has developed 8
warehouses in Hall County with water provided by various municipal water providers and the demand
for each project has been reviewed on a case by case basis based on tenant demand.
