Hall County previously authorized resolutions for condemnation regarding White Sulphur Rd. — Phase I. The County's land acquisition agent has engaged in negotiations with the property owner to arrive at just and adequate compensation for the portion of the property to be acquired. Negotiations have been unsuccessful to date. Condemnation is necessary in order to comply with the timeline for construction of the project.

Facts and Issues:

The White Sulphur Phase II project consists of intersection improvements at SR 365 and White Sulphur Rd. along with increasing travel lanes from SR 365 to the Inland Port from 1 to 3. This brings to a total of 3 travel lanes along this section.
