TrueRoll started marketing Hall County aproximately 2 years ago and Watson attended various presentations, interviewed principals of company, and consulted with colleagues before making a decision to prioritize implementation into the FY 2026 budget cycle.

End-to-End Homestead AdministrationTM: Full Suite: TrueRoll's world-leading end-to-end eligibility audit, monitoring, and change detection system for homestead administration includes both Application VetterTM and Proactive MonitoringTM. Delivered through a comprehensive, web-based administration suite. This solution manages the dynamic eligibility of property tax benefits-such as homesteads, exemptions, deductions, and credits-across new (paper or electronic) and existing homesteads as their eligibility changes.

Includes 25 Investigation Reports Delivered per year. Investigators will provide a specified number of Investigation Reports per year that contain a recommendation and annotated evidence of an unqualified homestead. Includes up to the same number of ad hoc investigation requests.

Additionally, Investigative Reports deliver information on potential applicants for higher exemptions giving the county the opportunity to communicate the eligibility to identified property owners and instructing them on how to apply for the applicable homestead exemption.

Fee is \$79,576 per year with a one time initial set up fee of \$1,500. This is a total 3-year subscription agreement if renewed each year for the full-term.

If the value provided by the Services in the form of the total of both the back taxes collected and the assessed value added to the tax roll that the Services help to discover is less than the Fee for the Initial Term, Company will refund the difference between the paid Fee and the Total Revenue Value Received after the Initial Term.
