THIS FIRST AMENDMENT TO CONTRACT NO. 062-43 (this "Amendment") is made and entered into as of the _____day of _____, 2025 ("Effective Date"), between HALL COUNTY, a political subdivision of the State of Georgia ("County"), and CHATTAHOOCHEE GROUP, INC. ("Contractor"), collectively, the "Parties".

WITNESSETH THAT:

WHERAS, the Parties have made and entered into that certain Contract Agreement, dated as of September 28, 2023, regarding certain construction services provided by contractor to County (the "Agreement"); and

WHERAS, the Parties desire to amend the terms and conditions of the Agreement as provided herein.

NOW, THEREFORE, for and in consideration of the foregoing, the public purposes, and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby do mutually agree to amend the Agreement as follows:

- A. <u>Amendment to Article #102 Contract, B. Compensation.</u> The Agreement is hereby modified and amended by replacing "Exhibit C Mandatory Cost Proposal Worksheet" with the Revised Cost Proposal Worksheet included in this Amendment as Exhibit A.
- B. Amendment to Article #102 Contract, B. Compensation. The Agreement is hereby modified and amended by replacing "Exhibit C Mandatory Cost Proposal Worksheet, which shall serve as the Guaranteed Maximum Price Lump-Sum Cost" with the following language:
 - a. "Exhibit C Mandatory Revised Cost Proposal Worksheet, which shall serve as the Guaranteed Maximum Price of \$3,226,813.25 for Quantity-Based Cost".
- C. <u>Amendment to Article #105 Contract Term.</u> The Agreement is hereby modified and amended by adding and clarifying the following terms:
 - a. "Until substantial completion on or before July 31, 2026, final completion on or before October 31, 2026".

NOW, THEREFORE, except as expressly modified and amended by this Agreement, the Agreement is and shall remain in full force and effect. The Parties hereby ratify and confirm the Agreement as modified herein.
