This is the first time that Hall County has received this type of funding.

Title IV-E is federal funding within the Social Security Act that provides federal matching funds to states to help pay for foster care, adoption assistance, and certain prevention services for eligible children and families. Previously, these funds flowed through the Georgia Division of Family and Children Services (DFCS); however, in 2024, the Federal Administration for Children and Families officially codified in the Federal Register that Title IV-E funds may be used to reimburse legal representation for parents and children in foster care proceedings.

The Georgia Office of the Child Advocate (OCA) receives Title IV-E funds from DFCS and disburses them to individual Counties.

Currently, Hall County fully covers the legal fees associated with representing children and parents in various types of DFCS court cases.

With the funding received, these funds will be budgeted and accounted for in a special revenue restricted fund for appropriate use each year.
