### Purpose of Request:

The Family Treatment Court Grant Program provides financial and technical assistance to local courts to develop and implement family treatment courts. This grant is separate from Hall County's annual Family Treatment Court grant. Hall County Treatment Services is requesting additional funding to support weekly meals during sessions, additional parenting and family counseling services, post-group incentives to support the family unit, and transportation vouchers to reduce barriers to treatment. These wraparound services ensure participants can fully engage in the program, supporting long-term recovery and successful family reunification.
