Executive Summary:						
Presenter: SW Recommendation: The Board of Tax Assessors recommends denial of the refund request for 2020, 2021, 2023, 2024 and 2025, while recommending a partial refund for tax year 2022 in the amount of \$2,251.12.						
Purpose of Request:		History:				

Consider the 2020, 2021, 2022, 2023, 2024, and 2025 real property refund in the amount of \$2,251.12 for overpayment of Hall County taxes regarding property located at 3001 Athens Highway (Tax Parcel # 15023 000040) to Gainesville Freezer, LP.

Taxpayer's agent requested a refund for **2020-2025** tax years. The basis of adjustment was the result of an inspection for a 2023 appeal where the Assessor's Office discovered the square foot was 258,201 as opposed to 262,778.

Statutorily, GA Code§ 48-5-380 (b), states that we are allowed to go back three years after the date of the payment of the tax to the county or municipality.

The tax agent for the property owner, Gainesville Freezer would need to involve an attorney to consider additional years.

The correct square footage was used in settling the 2023 appeal, as well as establishing the 2024 value.

The correct square footage was applied to the unit value for 2022 and the value difference is reflected below:

- 2020 Beyond statutory limit Resolved by consent order, not based on square footage - Litigation Required
- 2021 Beyond statutory limit Litigation Required
- 2022 262,778 \$15,232,300 (Digest) \$15,013,498 (Corrected)= Difference of \$218,802 2023 - 258,201 The square footage corrections were used to settle the 2023 appeal
- 2023 258,201 The square footage corrections were used to settle the 2023 appeal
- 2024 258,201 The square footage is correct / pending litigation (Superior Court). The value as of 1/1/2022 was reduced from \$15,232,300 to \$15,013,498.
- 2025 Tax Bills have not been issued for 2025 at this time and square footage is correct. Therefore, since no tax has been paid for 2025 no refund can be requested or made. There is nothing to refund.

Taxpayers agent wants a refund equal to 10% of the reduction for all years. The reduction of 10% is based on a settlement agreement of value, not based on square footage. Therefore, we recommend denial of this claim while recommending a refund of only \$2,251.12 for tax year 2022.
