Hello Beth,

As a Hall County GOP Precinct Chairman, I am writing to advise you of the views myself and many of my precinct citizens hold about the proposed data center at 2400 Okelly Road.

We are OPPOSED to the proposal as considered by the Planning Commission for the following reasons.

When data centers come to town, communities face both economic opportunities and significant environmental and infrastructural challenges, including increased demand for electricity and water, potential grid strain, higher utility costs for residents, noise and visual pollution, and potential impacts on local landscapes and water sources.

According to a 2025 study by the Gerald R. Ford School of Public Policy, "while data centers can bring tax revenue and some jobs, the scale of their resource consumption often outweighs these benefits, leading to pressure on local resources and increased energy costs for residents."

Disadvantages of a community data center include.

1. Significant resource consumption (especially water and electricity). In a letter dated August 28, 2025 from The City of Gainesville Water Resources, Nick Swafford, Permitting Services and GIS Manager stated that the City does not have adequate domestic water capacity to serve the proposed data center. The estimates from the applicant are low and unproven. There have been no estimates listed detailing the massive electric consumption that will be required and the impact it will have on local electric bills.
2. Noise and light pollution affecting residents and wildlife.
3. Potential air pollution from backup generators.
4. Potential negative impacts on property values.
5. Increased landfill waste from discarded equipment.
6. Data centers also require large plots of land, leading to habitat loss and increased carbon footprints.
7. Placing strain on local power and water infrastructure impacting increased utility costs for the local taxpayers.

The close proximity to neighborhoods, schools and churches make this an unsuitable location for a massive (almost 1 million sq ft) data center running 24 hours a day, 7 days a week, 365 days a year.

In addition, the Zoning Analysis indicates many unacceptable assumptions about the ramifications of this project.

ZONING ANALYSIS

The proposed use may place significant demands on water and/or power resources.

Staff is unable to determine the extent to which property values are affected by the existing zoning restrictions.

Staff is unable to comment on the impact of property values without a full market analysis. Often it is difficult to determine the effect of a development on adjacent properties until the development is completed.

The request may be out of scale with the needs of the immediate neighborhood as the use of a data center can place significant demands on water and/or power resources.

The continuing reference to "the applicant has provided responses to these concerns stating that the impact will not be harmful to the community." is biased, unproven and unacceptable.

Furthermore, the fact that Chris Braswell as a member of the Planning Commission has a financial interest in this project strains the very credibility of the planning commission in approving the data center at this location!

The Planning Commission needs to vote NO on this proposal.

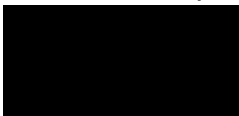

I am a resident of Hall County writing to express my strong concerns about the proposed Project Turbo data center at 2400 O'Kelly Road. Data centers today consume between 300,000 and 1,000,000 gallons of water per day for cooling. As a 900,000-square-foot facility drawing from Gainesville's municipal water supply—sourced from Lake Lanier—this project could consume hundreds of thousands of gallons daily for server cooling, exacerbating our region's vulnerability to shortages. We've seen Lake Lanier drop dramatically during the 2007-2009 drought, and 15 feet in 2023. With Georgia's data center boom already straining resources statewide, prioritizing this development risks household disruptions, higher utility costs, and ecosystem harm. Understanding how data centers have also negatively impacted community electricity supply should also be a key consideration in this matter.

I spoke with one county commissioner at the Flowery Branch Festival and he knew of the data center but was not aware of the impact to the water system or the electrical system.

While I understand public comment is not permitted at the October 6 Planning Commission meeting, I urge the Commission to recommend denial or require robust mitigations, such as electricity guarantees, binding water-use caps and drought contingency plans, before forwarding to the October 23 Board hearing. Our community's long-term sustainability must come first over short-term economic gains.

I hope this message finds you well. My name is Rich Elsarelli, and I am a resident and voter in Hall County. I am writing to formally express my opposition to the approval of Project Turbo.

Large-scale data centers such as the one proposed typically consume millions of gallons of water per day for cooling. Gainesville's municipal system, which draws from Lake Lanier, would bear this demand. As you know, our community has faced serious water challenges in the past, including the severe drought of 2007–2009 and water levels that measured 15 feet below full pool as recently as 2023. Other Georgia counties hosting similar facilities have already reported service disruptions, raising legitimate concerns about the risks we may face locally.

Given these realities, I believe citizens are entitled to full transparency before any approvals, incentives, or commitments are granted. Several critical questions remain unanswered:

- Who is the developer, and where are they headquartered?
- What corporate affiliations, partnerships, or financial backers are tied to this project?
- What binding commitments, if any, will be made to safeguard Hall County's long-term water security?

Without clear and verifiable answers to these questions, I respectfully urge you and your colleagues to oppose the approval of Project Turbo. The potential risks to our water supply and community wellbeing far outweigh the promises of short-term economic gain.

Dear Ms. Garmon,

I hope you are well. I am writing to submit public comments regarding Project Turbo, the proposed \$1.2 billion data center development off O'Kelly Road in southeast Hall County.

While the project's potential economic benefits are recognized, I remain deeply concerned about its impact on Hall County's long-term water security and incomplete transparency regarding environmental and fiscal details. Data centers of this magnitude can consume millions of gallons of water daily for cooling. Because Gainesville's municipal system draws from Lake Lanier, any significant new demand could heighten regional strain during drought cycles, such as those experienced in 2007–2009 and again in 2023, when the lake fell over fifteen feet below its complete pool level.

Before any approvals, tax incentives, or infrastructure commitments are considered, I respectfully request that the following questions be addressed publicly:

1. Developer Identity: Who is the primary developer, and where are they based?
2. Corporate Affiliations: What corporate entities, partnerships, or financial backers are involved?
3. Water Commitment: What specific, enforceable commitments will the developer make to safeguard Hall County's water supply over the long term?
4. Usage Estimates: What are the projected average and peak daily water demands, and how will consumption be managed during drought conditions or supply restrictions?
5. Cooling Technology: Will the facility use air-cooled, closed-loop, or reclaimed-water systems, and have sustainable alternatives been evaluated?
6. Infrastructure Impact: How will the required water and power infrastructure affect existing residential and agricultural users in the region?
7. Emergency Protocols: What mitigation plans are in place if Lake Lanier levels drop significantly or regional water restrictions are imposed?
8. Energy Demand: What is the projected electrical load, and will renewable or efficiency-based power sources be utilized?
9. Tax Incentives: What local or state incentives, abatements, or infrastructure subsidies are being offered, and what is the projected net fiscal impact on Hall County taxpayers?
10. Ongoing Oversight: Will a public oversight or liaison mechanism be established to ensure continued transparency regarding water usage, energy consumption, and environmental compliance?

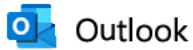

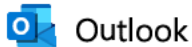

The people who should be paying for this astronomical increase in power consumption should be Companies, who generate billions of dollars in profit every year.

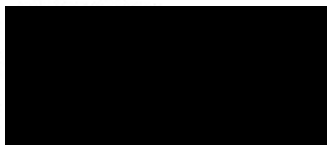

Dear Ms. Garmon,

I am a Hall County tax payer and a resident of the City of Gainesville, and I am writing to you with concerns about the proposed data center, Project Turbo, that would be going up on O'Kelly road. It is a known fact that data centers consume massive amounts of water and electricity to function, and as a resident of the nearby city that this facility will be impacting, I believe it is my right to voice these concerns to you, our local government officials.

Not far from Hall County, Newton County to the south of Atlanta, is already facing water hardships brought about by the Meta data center that was built in the county in 2018. Residents report not having any water flowing through the taps, and also that the water is brown and filled with sediment, as the local water facilities are unable to meet the load the data center requires, while still providing vital service to the residents of Newton County.

In an article published September 15th on Fox 5, it is noted that the City of Gainesville has already told the developers that they will not be able to meet the data center's water requirements if, "...the data center reached the high end of its estimated usage". This is an incredibly alarming thing to hear as a resident of Gainesville, because 'estimated range' doesn't have any fixed numbers and it could very well be a possibility that the data center exceeds the high end of this 'estimated usage'.

From a power standpoint, these data centers consume massive amounts of power to run all the equipment inside. Our power bills have already increased multiple times this year. Supposedly, this data center will be on its own grid and it will not affect residents' bills, but it sounds too good to be true. Most of our monthly bills and day to day expenses have increased exponentially over the past several months, and adding an even higher power bill would break many families, mine included.

Furthermore, the developers have said that this data center will provide only 150 jobs, which is such a small number when compared to the thousands of people that call Gainesville home, and who could be facing a future where clean drinking water is in short supply. Not to mention the over 200,000 residents of Hall County that would feel the strain as well, along with our neighbors to the south of us, who rely on the steady water release from Lake Lanier for their own drinking water and to maintain their waterways.

Project Turbo has claimed to bring in millions of dollars in revenue for the county, but how will it do this if it is only creating 150 jobs? I urge you to consider that the tourism Lake Lanier is able to sustain provides over **5 billion** dollars annually to the county, as reported by the Greater Hall Chamber of Commerce. The data center project not only threatens the quality of life to residents of Gainesville and her surrounding areas, but also the thriving tourist industry that many Hall County residents rely on, as the lake would face over harvesting to meet the needs of this data center.

As your constituent, I am strongly urging you to vote against Project Turbo, protecting Hall County's residents, our livelihoods, and our beautiful natural landscape.
