## NOTICE OF PUBLIC HEARING

The Hall County Planning and Development Department has a policy of notifying property owners within 500 feet when an application is filed with Hall County for consideration by the Board of Commissioners.

The application of:

**5111 Old Winder Highway | Rezone |** from Agricultural Residential 1 (AR-1) to Planned Residential Development (PRD) | on a 10± acre tract located on the east side of Old Winder Highway, approximately 2,051 feet from its intersection with Daylily Drive | Zoned AR-IV, Tax Parcel 15038 000076 (pt.) | Proposed Use: Addition of 38 townhomes to a PRD | Commission District 1 | Steven P. Gilliam, applicant

This application was remanded to the Board of Commissioners for reconsideration by Hall County Superior Court on October 14, 2025.

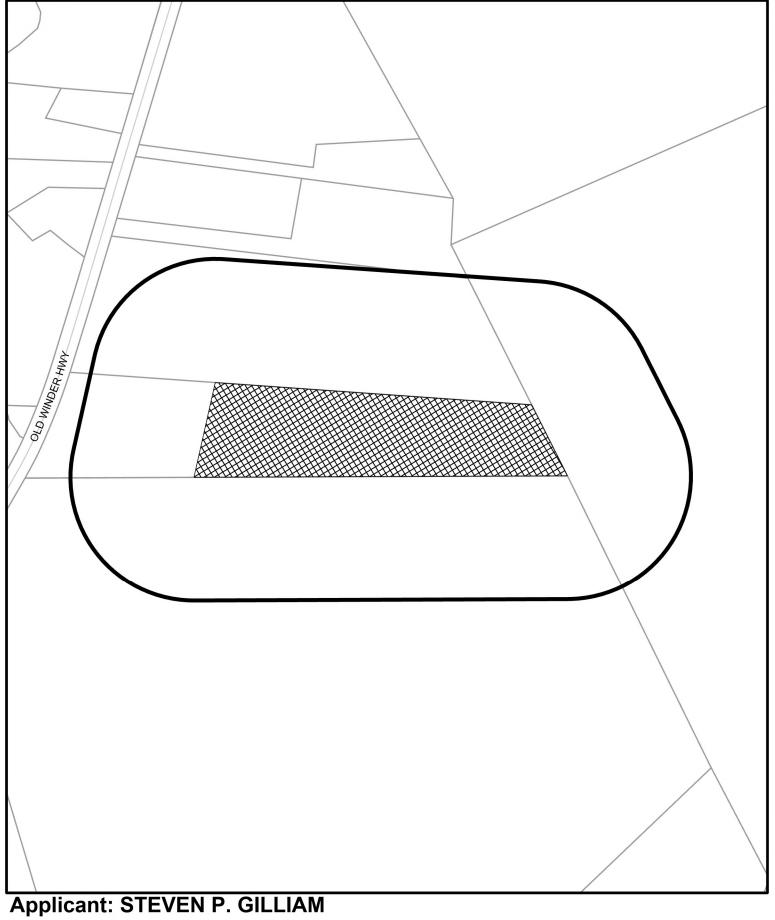

  (b) has made, within two years immediately preceding the filing of the proposed rezoning, campaign contributions aggregating \$250 or more to a member of the County Commission shall file a disclosure of contributions with the Planning Department at least five (5) days prior to the first hearing of the proposed rezoning by the County Commission. (OCGA § 36-67A-3[C]).
