Dear Commissioners,

I am writing to express serious concern regarding the proposed expansion and rezoning of Flowery Branch Winery to an agri-event space.

My husband and I have lived on Conner Road for 20 years, and while we absolutely support our local businesses and value their role in our community, this particular request would have a significantly negative impact on the residents who live along Conner Road. Conner Road is a very small, narrow country road. More often than not, residents are forced to pull off to the side of the road simply to allow oncoming vehicles to pass safely. Adding additional traffic associated with increased winery events would most definitely add danger to an already unsafe roadway. Additionally, the amplified voices, music, and instruments from larger events would be extremely disturbing not only to surrounding homes but also to the assisted living facility next door to the winery.

Of particular concern is access for emergency vehicles. Emergency responders already have difficulty navigating Conner Road, and they are frequently required to access the assisted living facility located directly beside the winery. Any increase in traffic congestion or roadside parking could further delay emergency response times, putting residents at serious risk.

Increased vehicle traffic related to winery events would only compound these existing issues and create an unsafe environment for residents, visitors, and emergency personnel alike. For these reasons, rezoning the property to an agri-event space would severely and negatively impact those of us who live on Conner Road.

My husband and I are hoping to attend the Hall County Board of Commissioner's meeting. However, in the event we aren't able, we authorize our neighbor, Sheila Humberstone, to represent us.
