The Hall County Planning and Zoning Department has a policy of notifying property owners within 500 feet when an application is filed with the Planning Commission.

**5953 & 5965 Yellow Creek Road | Special Use** | for rural business | on a 2.21± acre tract located on the south side of Yellow Creek Road approximately 340 feet from its intersection with Walden Road | Zoned AR-1; Tax Parcels 11105 000019 & 11105 00002C (pt) | **Proposed Use: Rural Business** | Commission District 2 | **Joshua Stover, applicant**

The Hall County Board of Commissioners voted at the Oct. 7 voting meeting to temporarily suspend the Hall County Planning Commission to complete an investigation, effective immediately.

While the suspension is in place, all new and pending planning and zoning applications, including rezoning, special uses, conditional use, and/or variance requests scheduled to be heard by the Hall County Planning Commission, will be heard by the Hall County Board of Commissioners to minimize delays in the application process.

The Board of Commissioners will hold a public hearing for final determination of the request at their meeting scheduled for 6:00 p.m. on Thursday, **January 22, 2026**, in the 2<sup>nd</sup> Floor Meeting Room, Hall County Government Center, 2875 Browns Bridge Road, Gainesville, GA, 30504.

The Board of Commissioners extend an invitation for you to attend this meeting or express in writing your opinion of this matter.
