Facts and Issues: The Hall County Sheriff's Office currently maintains a ten-year contract with Axon for safety equipment and services to be provided from July 2025 through July 2034. The Axon Justice Prosecution Package software will provide secured shared access between the Solicitor's Office and the Sheriff's Office. This creates faster evidence sharing, secure archiving, and clear proof of delivery.
