This letter is to express our adamant opposition to the Special Use Permit for the group home for people in addiction recovery at 4337 Mt. View Rd. in Oakwood. Last year, we moved to our present address at 4763 Propes Drive seeking a safe and peaceful residential neighborhood with minimal traffic.

This facility has added to the traffic and neighbors have informed us of disturbances there involving calling the police as well as instances involving traffic issues concerning persons leaving the premises. We have seen as many as twenty vehicles parked at this facility. One of our neighbors nearly missed having an accident when someone from the facility backed out onto Mountain View Road and caused them to swerve into the lane for oncoming traffic.

Therefore, in order to preserve the safety and well-being of our neighborhood, we herein request that you deny the Special Use Permit for 4337 Mt. View Rd. in Oakwood. Thank you for your consideration of this most important request.
