Purpose of Request: Approval and authorization for the Chairman to execute the Georgia Department of Transportation (GDOT) FY 2026 Local Roads Assistance (LRA) Grant application and cover letter for 5.94 miles of road resurfacing on six (6) various County roads, in the estimated amount of \$2,727,713.88, and if awarded, appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents. No match is required.

History: The Board has previously approved an application for FY25 LMIG funds in October 2024 and April 2025.

Facts and Issues:

Options:

The estimated total cost for resurfacing the six roads listed is \$2,759,416.00. LRA Funding will cover approximately \$2,727,713.88, and Hall County SPLOST VIII funds will cover the remaining \$31,702.39.

Based on the funding from GDOT FY26 LRA, the County is only submitting a condensed list that still maximizes the benefit of LRA funds but will allow Hall County to utilize the most recent road ratings for the Hall County FY27 Resurfacing List.

There is no cash match required for these funds.
