Dear Commissioners and Planning/zoning team,

We wanted to provide a brief update ahead of the upcoming meeting to assure you that we are actively addressing all feedback received.

We have met with all relevant Hall County departments to review requirements and expectations. We have also engaged with local residents and appreciate the valuable feedback and concerns shared.

We are currently finalizing a formal development plan if approved that will include:

- installation of a new commercial grade septic system
- fire suppression systems in the main and guest house
- installing a parking area to the rear of the main dwelling
- installation of sod and a row of Leyland Cypress trees near the road on the right side of dwelling for beautification and concealment
- screening of a commercial dumpster with a 6 foot privacy fence for improved aesthetics and concealment (also behind Leyland Cypress trees)

We are committed to being good neighbors and ensuring this project aligns with county standards and community expectations. Our heart is not to burden this community or become an adversary. We are committed to enriching our community by adding productive members of society to it.
